PRIVACY POLICY

This Privacy Policy ("Policy") explains how the website - https://bitdelta.biz/index.html ("Website," "Us," "Our" "We") collects and processes any information from any User (referred to as "You" or "Your") when You visit our Website, domains, sub-domains, pages, features, or content We own.

This Policy is of utmost importance. We want to ensure that You feel secure when visiting Our Website as well as in all Your interactions with us.

- 2.4 Fulfilling all legal and regulatory obligations that we have.
- 2.5 Analyzing user trends.

3. Transfer of Data

The data collected from the User may be transferred to Our Affiliate Companies, who may use the data to contact You to market their services and products.

4. Marketing

8. Cookies and Related Technologies

8.1 Cookies are small text files stored on computer drives and are widely used to improve Website functionality and user experience. All recent versions of browsers give You a level of control over cookies.

- 8.2 Our Website uses cookies as detailed under our Cookie Policy. You may delete cookies that are already on Your computer, and the browser can be set to prevent them from being placed.
- 8.3 You can adjust cookie preferences and also choose not to accept Our cookies. Choosing not to accept Our cookies may affect the quality and usability of the products and services We offer You. You can read more about Our Cookie Policy on Our Website.
- 8.4 In addition to cookies, we may also use other similar technologies on Our Websites, such as web beacons and pixels, to help us customize Our Websites and improve Your experience.
 - Web beacons and pixels usually take the form of a small, transparent image embedded on the Website or in an email.
 - They are used to track the number of users who have visited pages and acquire other statistical data.
 - They collect a limited set of data, such as cookie number, time, date of the page viewed, and a description of the page on which they reside.
